#### ARTICLES OF INCORPORATION

0F

#### TABB LAKES HOMES ASSOCIATION, INC.

The undersigned hereby associate to form a non-stock corporation under the provisions of Title 13.1 of the Code of Virginia of 1950, as amended, and to that end set forth the following:

- Name of Corporation. The name of the corporation is TABB LAKES HOMES ASSOCIATION, INC.
- Purpose of Corporation. The purpose for which the Corporation is organized is to govern the Common Areas of Tabb Lakes Subdivision, York County, Virginia pursuant to the requirements of the Declaration of Covenants, Conditions and Restrictions of Tabb Lakes, Ltd., a Virginia corporation, and the Preservation of Common Area and Maintenance Agreement between Tabb Lakes, Ltd., and the County of York, Virginia. Tabb Lakes is a residential subdivision, stage one of which is shown on a certain plat entitled, "Tabb Lakes, Section One, County of York, Virginia," prepared by C. K. Tudor, Engineers, Inc., dated December 10, 1984, and recorded in the Clerk's Office of the Circuit Court for the County of York, Virginia.
- 3. Members of Corporation. Every person or entity who is a record owner of any subdivision lot shall be a member of the Corporation. The foregoing does not include any person or entity who holds an interest merely as security for the performance of an obligation.
- Voting Rights. The Corporation shall have one class of voting membership consisting of all subdivision lot owners, and shall be entitled to one vote for each lot owned. When more than one person or entity holds an interest in any lot, all such persons or entities shall be members. The vote for such lot shall be exercised as they among themselves shall determine; but in no event shall more than one vote be cast with respect to any one lot.
- Board of Directors. The members shall meet at least annually and shall appoint a Board of Directors which shall manage the activities of the Corporation. The initial Board shall consist of three (3) Directors. who need not be members of the Corporation. The number of Directors may be changed by amendment to the Bylaws of the Corporation.
