Lake Services Inc. will provide the necessary manpower, materials and equipment to mechanically dredge and dispose of the sediment material from Tabb Lakes #1 within the designated dredge prism defined by others. Lake Services Inc. will give notices and comply with all laws, ordinances, rules, regulations and orders of any public or private entity bearing on the performance of the Work performed by Lake Services Inc.

Mobilization:

- Mobilize necessary equipment to designated transfer/staging area site.
- Set-up transfer/staging area site per approved plan.
- Set-up dredging equipment.
- Install turbidity curtain as needed across lake just outside of limits of disturbance to insure sediment material that is stirred up during the dredging process stays with the dredge prism area.

Mobilization Price: \$ 41,064.00

Dredging Operation and Disposal:

- Dredge sediment material from the designated area of Tabb Lake #1, depth to be determined by customer.
- Dredged material will be placed into a material barge; barge will be shuttled to the transfer site area where the material will be loaded into sealed gate dump trucks.
- Sediment material will be hauled to an approved disposal site for dumping.

Dredging Operation, Hauling and Disposal Per Cubic Yard Rate: \$42.01

Site Restoration and Demobilization:

- Remove dredging equipment from site.
- Remove mats and materials from transfer area site.
- Grade out disturbed areas; install topsoil as needed to level low/uneven areas.
- Install grass seed and fertilizer to disturbed areas; apply straw cover to seeded areas to insure stabilization.
