1. #### 2. Old Business

- A. The Board of Directors discussed the forum for the lakes meeting and that the required quorum is 112 homeowners voting. Another mailing will be sent out.

- D. The Board discussed putting the Covenants on the website, Clint Flanagan has request a good copy to attempt loading the covenants using optical character reading software.

### 4. Committee Reports:

- A. Covenants Review Committee report: 100 Tiger Paw path Mr. And Mrs. Devin Swallow is the November Yard of the Month. They were presented a congratulatory letter, \$25 Gift Certificate to Andreas, and the sign was placed in their yard on November 1, 2004.

## C. Storm Water Committee Report

- (1) Lou Lafrenaye discussed the Emergency Response Meeting to tentative for February 16, 2004, this will be held at the Tabb Library. Lou is currently in contact with the Yorktown Fire Department and is working on draft for this meeting.
- (2) Recently we have had substantial rains. Lou has checked our inflow and outflow pipes and noted that the pipe by the junk yard was plugged. Volunteers are needed to clear the area by the lakes.
- (3) Lou Lafrenaye discussed looking into the pros and cons in a extension pipes on the existing pipes.
- (4) David Horne is in the process of contacting several lake maintenance companies to request information and aeration bids.

#### D. Treasurer's report

- (1) Charles Rossi notes that there is \$81,174.38 in the account. TLHA accounting year will be set from October 1 to September 30, with October being the first month in the fiscal year.
- (2) Peninsula Data Service Center will be preparing our next mailing for the assessments and these will be sent out in January 2005.
- (3) Charles will be transferring \$10,000.00 from the checking to the savings account.
- (4) Taxes 2005 with Darrell Harris vacant we discussed taxes, Charles received a coupon book for the 2005 tax season.
- (5) Signatures for the Bank account require 2 signatures and this will be looked into further
