2. <u>Approval of Previous Minutes</u>: Mr. Ebert made a motion, which was seconded and unanimously approved, to approve the minutes from the BOD meeting held November 19, 2019.

3. <u>Home Owner Forum</u>: No homeowners present; no issues discussed.

4. Committee Reports:

- a) <u>Newsletter Editor</u>: No coordinator present; no report given.
- b) <u>Website Editor</u>: Mr. Flanagan emailed his report that he completed the usual website maintenance and updated the homeowners' electronic distribution list.
- c) <u>Beautification Committee</u>: Ms. Hurst reported the Holiday Decorations Contest winners via email. The nighttime contest winner was 401 Bridgewood Dr. and the daytime winner was 205 Heath Place.
- d) <u>Lakes Management</u>: Mr. Ebert reported a potential issue with the Lake 2 aerators.
- e) <u>Storm Water</u>: Mr. Lafrenaye emailed his report on efforts to remove debris that has accumulated at the outflow pipes at the end of Lake 1. York County has been contacted and will be providing some assistance.



- f) <u>CERT</u>: Mr. Lafrenaye reported no new developments.
- g) <u>Welcoming Committee:</u> Mr. Ebert reported that he has welcomed seven (7) new residents since the last Board meeting.
- h) <u>Neighborhood Watch</u>: Mr. VanHouten emailed no new developments.
- i) Grounds Maintenance: Ms. Knaub reported no new developments.
- j) <u>Architectural Review (ARC)</u>: Ms. Knaub reported there has been one (1) ARC request submitted since the last Board meeting.
