WHO IS THE TLHA BOARD?

Welcome to the two new additions as Members-At-Large to the Tabb Lakes Homes Association (TLHA), Bob Spell and Bill Hopkins. They have volunteered to fill the two positions recently vacated. Their terms are only for the remainder of the year, until the next scheduled board elections.

WHAT IS THE BOARD THINKING?

FREEDOM having a historical significance in York County, brings a different perspective to the TLHA. Where is the balance between your FREEDOM to choose what to do with your home, your land, your property, your friends and your family and the FREEDOM to live in a clean, quiet, relaxing, friendly, productive, safe, attractive and VALU-ABLE neighborhood? The motto of Virginia being Sic Semper Tyrannis (Latin for "Thus Always to Tyrants"), puts the burden on the TLHA to serve our neighbors instead of dictating to them. The members of the committees and the board being volunteers have shown care in trying to do what's best for our neighbors. It hurts when a neighbor hurts. Life is better when our neighbors are happy.

LEGAL ACTION

FREEDOM also comes with choices. FREEDOM to choose legal action when a disagreement occurs was the path taken recently by a neighbor against TLHA. The dispute was taken to small claims court. The board decided to have it elevated to civil court so that our attorney could be present for legal protection. The judge decided in favor of the board. There was no celebration. Both the neighbor and the board lost out in different ways. Now the matter has been appealed to the circuit court. What will be the outcome? That remains to be seen.

DISPUTES AND ENFORCEMENT

FREEDOM means we will not always agree. One person will call a color offensive, while the owner may like it because the color holds a special memory (a prom dress or grandma's living room in 1966 when anything was groovy). Is there anyone here that did not exercise a freedom of choice to live in a neighborhood with an association? Okay, so you don't get to choose your neighbors. 
unnoticed by realtors and visitors alike.

FIGHT THE BITE! MOSQUITO CONTROL INFO ON THE WEB



Everything you need to know about preventing mosquitoes in your backyard and protecting yourself when you venture outside can be found on the Mosquito Control Web site: yorkcounty.gov/eds/mosquitocontrol.htm.

Information available includes: prevention, protection, West Nile Virus, aerial and ground spraying, the role of mosquito monitor volunteers, and more.

To report a mosquito problem, please visit the site and select "EDS Customer Service

System." This fillable form will allow you to quickly and easily submit information regarding the abundance of mosquitoes in your area. If you do not have easy access to the Internet, call Mosquito Control at 890-3790.

Also available via telephone is the Mosquito Spray Hotline: 890-3793. This recorded message will let you know where and when mosquito spraying is scheduled.

TIPS FOR SELECTING A CHIMNEY CONTRACTOR — JIM BOSTAPH

The first thing to realize is that the chimney profession is not a regulated trade in Virginia. This means that anyone can call themselves a chimney company without any training or testing. So how do you protect yourself; what are some things to look for?

Licenses:

Does the company you are dealing with have a city business license?

Do they have a Virginia General Contractor's License? Do they pull permits on larger repair jobs when permits are required?

Certifications:

There are three nationally recognized chimney certifications. The Chimney Safety Institute of America (www.csia.org) issues a **Certified Chimney** Sweep certification. Fireplace Investigation Research & Education Services (www.-f-i-r-eservice.com) issues a Certified Inspector certification. The National Fireplace Institute (www.nficertified.org) issues a certification

based on knowledge of fireplace safety, venting requirements, and installation. The certifications each require periodic retesting or renewal through continuing education. Each of these websites can tell you who has earned

these certifications in Virginia.



Are they members of the Better Business Bureau (www.bbb.org)? If so, what is their history and rating? Are they members of the National Chimney Sweep Guild or the Virginia Association of Chimney & Hearth Professionals? Are they members of the national Fire Protection Association? These memberships show dedication and commitment to the industry.

Insurances:

Do they carry Workmen's Compensation, Liability, Vehicle, and Professional Contractor's Insurances? A worker injured on your property can draw from your homeowner's insurance unless they carry Workmen's Comp. Liability insurance covers "completed operations" or work performed in the event bad things happen later. Professional Contractor's Insurance is similar to an Errors & Omissions policy. If the contractor misses something that could have or should have been seen, there is coverage in the event something bad happens as a result.

A company that is doing business without all of these things, or even without one of these things, can afford to do work at a much lower price. If price is not the most important factor to you, ask the contractor about licenses, certifications, memberships, and insurances.

YCSD REGISTRATION

Are you new in York
County or do you have a new kindergartener? In order to register your child with the York
County School Division, you must provide the following required

- The child's original certificate of birth (or certified copy)
- A child's social security card

records:

- A current School Entrance Physical and Immunization Certificate (MCH-213F)
- Proof of York County residency

Children entering kindergarten must be five years old before Sept. 30. Enrollment requirements are available at each school and on the school division's website at http://yorkcountyschools.org.



The National Hurricane Center issues a hurricane watch to alert specific regions when hurricane conditions are forecast for the area within 36 hours. This watch should trigger your family's disaster plan, and you should be protecting your home and property from a storm. Monitor weather reports via television or radio to stay informed.

HURRICANE WARNING-


Sustained winds of 74 mph or greater are forecast for the area within 24 hours. All precautions must be taken immediately.




