In this Newsletter, I'd like to focus on a couple of areas around the community that affect the health, security, and the safety of our families.

Your association regularly receives complaints about speeding vehicles, particularly on Tabb Lakes Drive, Bridgewood Drive and Gardenville. In the past, we've tried to get more active enforcement from York County: but this remains an ongoing issue. Your Board of Directors will renew efforts to get County support, but meanwhile there are things you can do to help this situation. For one, keep in mind the old adage that "the squeaky wheel gets the grease." In other words, when you observe a vehicle speeding down your street, whether it's your neighbor or someone cutting through the neighborhood from Greenlands, pick up the phone and report it to the **Sheriff's Department** at 890-3630. Even if you can't read the speeder's license plate number. the increased "noise level" we can generate will have a positive effect in helping us get attention to the problem.

As we move into Spring, we can also expect to see more driving activity by our younger drivers, not to mention larger numbers of children playing in the streets after school and on weekends. If you have a teenage driver at home, be sure to remind them to keep their speed down and maintain a sharp lookout for children. It also helps to reiterate that, in our neighborhood, we have a \$200 additional penalty tacked onto the price of a speeding ticket and hold them personally responsible to pay the full amount if they are caught. We're often asked: "Why not install speed bumps on our main thorough fares?" The short answer is that our streets are maintained by VDOT, not the association, and VDOT rules prohibit installation of speed bumps on public highways. Thus, we have to rely on outside help and reminders.

Moving on to another subject, let's talk briefly about home security. Again, with warmer weather, we often see a spike in the number of attempted break-ins, vandalism, and petty crime. One of the biggest deterrents we have to crime is the presence of good street lighting. Around the neighborhood we have numerous "night watch" streetlights. The Association pays the electricity bill for the lights, but responsibility for maintaining the lights falls to Dominion Power. If you see a street light that is out, don't assume your Board is going to make the call. Pick up the phone and notify Dominion at 888-667-3000 (continued on page 2)

and they'll submit a work order on your behalf. It's an easy process: just give them the address closest to the streetlamp.

That said, our night watch lights are spaced every 4-5 homes and don't provide enough lighting to cover everyone. You can make a major difference here by replacing your garage

and porch lights with sensor lights that come on when anyone approaches the house. You'll not only save electricity by not having to leave a light burning all night, but the addition of your light when there are people passing by will serve as a strong deterrent to crime and vandalism by denying criminals the cover of darkness. Sensor lights are readily available in the hardware sections of local stores. They're easy to install, and falling prices on these units have made them very affordable.

If you have additional ideas for improving security and safety of the neighborhood, please pass them along to any Board member; our contact numbers are listed on the first page of this newsletter.

At this writing, we still have no volunteers to run our **Neighborhood Watch program**. We would love to have new volunteers to reinvigorate this much-needed program. If you care enough for the safety of your family and your neighbors, won't you please consider getting involved?

STAY SAFE ON THE BUS (FROM YORKTOWN'S "CITIZEN NEWS")

These bus safety tips, provided by the YCSD Transportation Department, will help our students stay safe on the road.

- STOP on either side of the road when a bus displays flashing red warning lights and extends the stop signal arm.
- Do not pass the bus until the lights are turned off and the stop signal arm is retracted.
- Remember, a bus has to stop at all railroad crossings.
- Be nice, and allow room for a bus to merge if the driver has turned on its sig-

- nal.
- Encourage children to speak softly when riding the school bus so they do not distract the driver.
- Never walk behind a bus. Always walk at least 10 steps away from the bus and be sure you can see the driver's face.

 Children should follow all bus safety rules posted at the front of the bus.



TREASURER'S REPORT-CHARLES ROSSI

As Treasurer of the Tabb Lakes Homes Association, it is my responsibility to keep track of the Association's income and expenses, pay the bills, and make regular reports to the Board of Directors at their monthly meetings.

Here is a general overview of where our money comes from and how it will be spent in the upcoming year:

The Association's income this year will be approximately \$70,600. Of this, \$69,800 comes from homeowners' annual Association dues, \$650 comes from interest on our tax-free bond fund invest-

ments, and \$150 comes from newsletter ad sales.

Our <u>expenses</u> this year should be approximately \$67,000. Our biggest expenses, on an annual basis, are:

- Contingency Fund -\$22,300 that is set aside every year for possible future major lake expenses, although the Board can re-allocate it if needed. We have accumulated about \$200,000 in this Fund over the years.
- Electricity -\$14,000 (power for our streetlights, entrance lights, and lake fountains & lights).

- Property Management \$9,000
 (Covenant Enforcement and Architectural Review tasks that are handled by Cox & Lee Management)
- ◆ Lake Maintenance -\$8,000 (water treatments to control algae and other aquatic plants; maintenance and repair of the lake fountains; water quality tests).
- Grounds Maintenance-\$6,000

 (landscaping of our entranceways on Rt. 17 and Rt. 134, and the common area near Lake 1)
- Insurance \$4,000 (liability insurance for the Association

- and property insurance for our entranceway brickwork and signs)
- Legal Fees -\$1,500 (costs incurred when disputes involving covenant compliance or payment of dues must be settled in court)
- The remaining expenses include:
 postage, taxes, water for our entrance sprinklers, dues collection expenses, and newsletter printing.

Any comments or suggestions from homeowners are always welcome.

Statewide
Tornado Drill
Annual drill set for
March 20 at
9:45 a.m.

Last year, 51 tornadoes hit Virginia, the second highest number on record. Ten people died, more than 100 were injured, and 212 homes and 17 businesses were destroyed. Nearly every part of the state was affected.

All Virginians need to practice taking cover from tornadoes. Plan now to participate in the Statewide Tornado Drill, set for Tuesday, March 20, at 9:45 a.m. Every home, business, organization, school and college can hold a tornado drill. If you can't participate at that time, then choose another time or date the most important thing is to have a drill. If you have children, teach them what to do in the event of a tornado.

To start the drill March 20, the National Weather Service will send a test tornado warning at about 9:45 a.m.

that will trigger a tone alert and message on NOAA Weather Radio. This will prompt local radio and TV stations to broadcast a test message.

- Go immediately to a safe area – usually the lowest level of your home, office or school.
- Move to a windowless interior room, closet or hallway.
- Take a "drop, cover and hold" position.
 This means crouch as low as possible to the floor, facing down and covering your head with your hands.
- Get instructions on how to hold a drill at www.ReadyVirginia. gov.

In the meantime, get a NOAA Weather Radio with SAME alerts. This is the fastest way to get tornado warnings. These radios are available at electronics and sporting goods stores, discount and department stores, and online. Some have strobe lights for those



battery-powered models in case the power is out, and many also have AM/FM bands so you can hear local radio stations that may be broadcasting emergency information.

Smoke Detectors and Carbon Monoxide Detectors Save Lives

Make sure you install these in your home and garage and inspect them regularly.

- Consider purchasing combination smoke/carbon monoxide detectors.
- Install them in sleeping areas and on every level of your home.
- Install them away from air vents.
- Interconnected smoke alarms are best because if one sounds, they all sound.
- Test smoke alarms monthly. Change alkaline batteries at least once a year. Use a date you already know as a reminder, such

- as your birthday or when you change your clocks.
- Prepare and practice a fire escape route with everyone in your home, including children.

"Dual Pol" Radar comes to Virginia

The National Weather Service offices in Virginia are getting new radar technology that will help improve weather forecasts in the commonwealth. The new technology, called polarimetric Doppler radar (also called dual-polarization radar), will improve total precipitation estimates, ability to track heavy rainfall, ability to differentiate precipitation types and provide new severe thunderstorm and tornado signatures. The radar at NWS Wakefield has already been upgraded. For more information on this new radar, go to the following NOAA web site

LAWN CARE—RON MADDOX

Whether your approach to lawn care is do-it-yourself, or you are fortunate enough to have a service do the work for you, here is a quick list of springtime Do's and Don'ts for having a healthy lawn without spending any more than you have to spend. Maybe it will just jog your memory.

You should check with a nursery regarding advice for your particular type of lawn grass:

<u>Do's</u>

Pre-emergent Weed Control: Do use a pre-emergent crabgrass and weed seed control that contains Prodiamine™ as the active ingredient. Unlike other pre-emergents that only last for up to 90 days, Prodiamine continues to kill weed seed of all types all spring and summer.

Pre-season lawn mower check: Do get your mower out early and start it up to be sure that everything is working properly. Also, if your mower's blade needs to be sharpened, it a good idea to get this into a service shop early, before they get swamped when the mowing season starts.

PH testing: Do have the PH level of your lawn tested professionally every 2-3 years. This will give you (or your service provider) a better idea of what the specific needs are of your particular lawn.

Directions on the labels: Do read all product labels and follow the recommended rates of application for any lawn product.

Raking: Do rake up any leaves that have trapped themselves under your shrubs. This will allow air to replace the leaves and help aerate and dry the soil that has gotten soaked over the winter.

Don'ts

Pre-emergent Weed Control: Don't apply pre-emergent weed control if you have seeded your lawn, as the pre-emergent weed control will kill the developing seeds. Instead wait until after your grass seed has germinated and started to grow.

Grass Seeding: Don't plant cool season grass seed in the spring. Planting in spring exposes the seedlings to fusarium blight and other disease pathogens, plus the new grass will be exposed to the summer heat before their roots have had a chance to develop. Fall is a better time to plant cool season grass seed.

Fertilizer: Don't overfertilize. A little fertilizer is good, but too much too early in the spring can cause problems like lots of top growth. Although it may look nice at first, top growth comes at the expense of your lawns' roots. Rather than go heavy on fertilizer in the spring, it is better to fertilize lightly throughout the season.

Pest Control: Don't use pest control as a preventative measure. Pesticides are expensive and some can cause significant damage to the environment. If you don't have

an actual problem with lawn insects, then don't use insecticides. And similarly, if you don't have a disease problem, then don't use fungicides.

SUMMARY

We hope this list has helped you understand some quick Do's and Don'ts for caring for your lawn. And that it helps you get your lawn off to a great start this year.
